- A. High School Career Experiences- Mrs. Freiwald, Mrs. DelConte
 - Mrs. Freiwald and Mrs. DelConte spoke about job shadowing, PFE, and BCTC opportunities.
 - Mrs. DelConte introduced three students who have all taken part in different career exploration opportunities.
 - Hannah Balthaser, Isabella Forte, and Riley Mohn were the three students who addressed the board and shared their experiences.
 - Hannah Balthaser is a Senior here at Hamburg High School, her PFE is on her family farm, Northkill Creek Farm. Hannah explained that this experience was extremely helpful in determining what she would like to focus on in the future, which is genetics. She thanked the board for this opportunity.
 - Lolly Lesher mentioned that Hannah's farm has been selected for a global convention. Hannah explained that it takes place at a different location every year and this year her family farm was selected to be one of the tour spots.
 - Isabella Forte is also a senior here at Hamburg High School, she is a part of the Healthcare Senior Only Internship Program.
