BOARD DISCUSSION – Customizing Literacy

Mrs. Freiwald and Dr. Mextorf began the discussion with Imagine Learning. Explaining with Imagine Learning students enter a world of dynamic language and literacy instruction that's research based, first language supported, data driven, and incredibly fun to use. Say goodbye to one-size-fits-all instruction and hello to a strategic, research based curriculum that meets students at their own level. There are ongoing assessments. The curriculum they need – with the data teachers need.

Second Grader, Rowyn Elliott was present and demonstrated to the board how they use imagine learning in her classroom. Rowyn stated that she along with her classmates really like Imaging Learning.

Mrs. Cucciuffo explained how Imagine Learning can provide support in 15 languages. She explained how a kindergarten student who was a refugee came with his father to live with relatives and could not speak or understand English. He cried every day. Imagine Learning was available in the dialect. Mrs. Cucciuffo said you should have seen the smile on the child's face when he was able to understand.
